**SCHEDULE**

Judges' briefings and walkthroughs will begin on Wednesday-Sunday at 7:20 AM, with the first run at 7:40 AM in Ring 2. In Ring 1, Judges' briefings and walkthroughs will begin on Wednesday-Sunday at 7:30 AM, with the first run at 7:50 AM. Each day will begin with declared conflicts in the first two classes followed immediately by the first scheduled jump height. Height order and class order in each ring, each day, is as below:

Walk, walk, run procedure may be used when appropriate to save time.

## **MEASUREMENT REQUIREMENTS**

All dogs must have a valid Agility Height Card issued by AKC or be measured prior to any runs (except dogs jumping at the 24" height) at a trial or group of trials. Ms. Karen Wlodarski has graciously agreed to serve as a VMO, in addition to one of our judges, Mrs. Diane Fyfe. Any entered dog needing an official measurement is required to be measured. It is suggested that you come early morning while courses are being set to be measured. Being measured prior to your run is the responsibility of the exhibitors.

## **VOLUNTEERS**

We sincerely thank all of you who are willing to volunteer to help at these trials. Without a large number of workers these trials would not be possible. On-line sign up for workers is now available. This should simplify the process and offer the flexibility of making changes if your plans should change. Sign-up sheets will also be posted at the trial for last minute changes. Only those registered as "Unloaders" may enter at 11:00 AM on Tuesday to set up and then unload the equipment and build courses for the trial. Unloading is scheduled for Noon. All other exhibitors may enter on Tuesday between 2:00 PM and 5:00 PM to unload and set up.

## **DIRECTIONS TO SITE**

From Atlanta (or North): Take I-75 South to the Macon By-Pass (I-475). Take the Macon By-Pass. It will put you back on I-75 South. Take Exit #135. Go left to the Agricenter. Enter at the East Gate.

From South: Take I-75 North to Exit #135. Go right and proceed as above.

## **PARKING NOTICE**

Enter the Agricenter through the East Gate. Please follow directions to designated parking for Agility. Do not park in areas other than the designated areas. **Parking at the immediate rear and inside of Reaves Arena is limited to loading & unloading and trial officials (by permit) only. You will be notified and receive a parking pass if you are designated to park in these areas.**

## **NEW LOADING AND UNLOADING INSTRUCTIONS**

**in response to a number of requests, we have made arrangements for unloading and limited parking at the front of Reaves Arena. This will be a self-policing area, and its continued use is dependent on orderly and safe use. Do not block doors. Do not block passageways for vehicles, golf carts, and pedestrians. Do not park in the designated handicap spaces unless you have a state issued handicap pass. Observe any and all signage that may be posted. Courteously and expeditiously observe any instructions given by PBC or GNFA officials. If the parking area is filled, you may unload leaving lights on and motor running. After unloading, you will need to leave and return to the normal designated agility parking. You will enter through the RV entry gate passing through RV parking areas. The utmost caution must be observed as these areas are heavily traveled via golf carts and pedestrian humans and dogs. You must obtain a pass at the Trial Chairman's table inside Reaves to access this area. Unsafe and/or unsportsmanlike behavior in this area may result in this area no longer being available to agility exhibitors. You did well last year – keep up the good work!**

## **ACCESS TO BUILDING ON TUESDAY, APRIL 9**

Reaves Arena will be open for exhibitors to set up between 2:00 PM and 5:00 PM on Tuesday, April 9. Only committee members and designated "Unloaders" (you must be signed up) are permitted to enter at 11:00 AM.

## **HOTELS/MOTELS**

These trials are a part of the Peach Blossom Cluster of Dog Shows and other associated events. All exhibitors are required to observe the Cluster hotel/motel regulations as published in the Cluster premium list. ## **IMPORTANT NOTICE**

We may water the arena floor and/or spray for insects any evening after the trial. Exhibitors are cautioned to take action to prevent damage or contamination to personal property left in the building. All dogs must be removed from the building within ½ hour after the last run. Exhibitors are responsible for their personal property at all times.

## **DOGS ON LEASH**

AKC Regulations state 'Dogs shall be on leash at all times when on the show grounds except in the ring and at the warm-up jump area.' We must strictly enforce this regulation as it is also an Agricenter rule.

## **GNFA MECHANICAL EQUIPMENT POLICY**

Skateboards, scooters, roller skates, hover boards, roller blades, and other similar mechanical equipment are prohibited within all property known as the Georgia National Fairgrounds & Agricenter. This policy will be strictly enforced.

## **CONFLICTS**

It is the exhibitors' responsibility to be at the ring with their dog when it is their turn to run. We would like to accommodate each and every conflict but that will more than likely be impossible and you may have to make a choice. We believe the following will resolve the majority of legitimate conflicts.

Conflicts within a jump height will be resolved by the Gate Steward. Handlers with multiple dogs in a jump height may have the first dog moved forward or the last moved later. The order of the dogs in question may not be changed.

Otherwise, exhibitors with conflicts in the first two classes each day will run at 7:20 AM. Conflicts in other than the first class in each ring, in most cases, will be accommodated by running first in your class. Only in the direst of circumstances may a handler in any of the Excellent/Master Classes be allowed to run after their jump height has been completed and must be approved in advance by a member of the Trial Committee.

Requests for changes in assigned running order are granted at the discretion of the trial committee and only when that change does not disrupt the smooth flow of the trial. You must declare your conflict the day prior, i.e., Friday for a Saturday conflict. If you have a conflict for Wednesday, check in with us Tuesday afternoon when you arrive or notify us via e-mail no later than 6:00 PM, Monday, April 9, 2018. You will fill out a brief "conflict" form. This will insure that we will be able to pull your scribe sheet and have it ready for 7:20 AM or other designated time for

**your run. Exhibitors who are not at the line at their assigned time to run and have not declared a conflict and had it approved will be marked absent.**

**If you declare a conflict, and are assigned a new running time or order, that will be the time you are required to run. If you are not present at that time you will be marked absent and will not be permitted to run at any other time.**
