AMERICAN KENNEL CLUB'S CANINE GOOD CITIZEN BECOMES AN OFFICIAL AKC TITLE

NEW YORK, NY...IN CELEBRATION OF DOGS WITH GOOD MANNERS AT HOME AND IN THE COMMUNITY, BEGINNING JANUARY 1, 2013, PASSING THE AKC®'S CANINE GOOD CITIZEN® TEST CAN BE RECOGNIZED AS AN OFFICIAL AMERICAN KENNEL CLUB® TITLE FOR ALL DOGS.

Since the program began in 1989, the CGC® has been considered an award. Dogs that passed the 10-step test received a certificate, but CGC was not listed on the dog's title record. Now as a result of frequent requests from dog owners and instructors, owners of dogs registered or listed with AKC will be able to use the CGC suffix after the dog's name and include Canine Good Citizen on their dog's official title record.

We're pleased to celebrate the accomplishments of the thousands of dogs that pass the Canine Good Citizen test each year by offering CGC as a title, said Mary Burch, PhD, director of AKC's Canine Good Citizen program. The CGC program tests the skills that make dogs a joy to live with and many owners have expressed the desire to officially add this badge of honor to the end of their dog's official AKC name. We hope that CGC is the first of many titles these dogs earn.

For dogs that pass the test on or after January 1, 2013, owners will be able to choose from two options on the CGC test form: CGC as a title or CGC certificate only.

CGC as a title: CGC will be listed on the dog's official AKC title record. The dog must be registered or listed with AKC (via an AKC registration number, PAL listing, or AKC Canine Partners listing). Owners will receive the CGC certificate and may use the suffix CGC after the dog's name.

CGC certificate only: CGC will not appear on the dog's official AKC title record.

Owners whose dogs earned the CGC award from January 1, 2001 onward may convert the award into a title by filling out and submitting this form.

AKC began accepting CGC title applications on Monday, December 17, 2012. The processing of all CGC title application will begin Wednesday, January 2, 2013. Learn more about CGC as a title at <http://www.akc.org/events/cgc/title.cfm>.

To compete or earn any AKC titles, including the new CGC title, dogs must have an AKC number: an AKC registration number, a Purebred Alternative Listing (PAL) number or an AKC Canine Partners' number. If your dog doesn't already have an AKC number, learn how to obtain one at www.AKC.org

The Canine Good Citizen program is a two-part program that stresses responsible pet ownership for owners and basic good manners for dogs. Many dog owners choose Canine Good Citizen training as the first step in training their dogs. The program lays the foundation for other AKC activities such as obedience, agility, tracking, and performance events and also serves to enhance the bond between owner and dog, making dogs a pleasure with which to live. Thank you to our President Jerry Ceresini for judging our Bests. Polite, welcoming and polished, you did a great job.



THE ELEPHANT IN THE COURTROOM

Don't worry, kids. Elephants are staying in the circus. And the animal-rights activists who tried to drive them out are paying a price for their abusive litigation. On Friday Feld Entertainment, producer of the Ringling Brothers and Barnum & Bailey Circus, announced a legal settlement under which the American Society for the Prevention of Cruelty to Animals (ASPCA) has paid \$9.3 million to the company.

Yes, you read that correctly. A special-interest group sued a corporation and in the resulting settlement it was not the business but the activist group that had to write a check. The case is an example of how the ASPCA has become increasingly politicized and much different from the nice outfit that looks out for the well-being of homeless and lovable dogs and cats.

Twelve years ago the ASPCA and other activist outfits joined with a former Ringling employee to sue the company under the Endangered Species Act. The claim was that Ringling was abusing Asian elephants. Perhaps the activists figured the circus would fold up its big top and write a check.

Not on Chairman and CEO Kenneth Feld's watch. He's been working in the family business since 1970 and tells us that he's "proud of our animal care and I'll put it up against anyone in the world."

After nine years of litigation, a federal court found that the plaintiffs had no standing to sue under the Endangered Species Act and that the former Ringling employee was "not credible" and "essentially a paid plaintiff and fact witness" whose only source of income during the litigation was the animal-rights groups that were his co-plaintiffs.

Mr. Feld says the \$9.3 million payment from the ASPCA represents less than half of what his company has had to spend defending itself against the "manufactured litigation" from the activists. But he seems likely to recover more. His company is continuing its litigation against the Humane Society of the United States, the Fund for Animals, the Animal Welfare Institute, the Animal Protection Institute United with Born Free USA, the former employee and the lawyers who prosecuted the bogus case.

"This goes way beyond economics," says Mr. Feld. He adds that the "level of harassment" that his elephant trainers undergo from activists is almost "unbearable" and that "the activists are trying to bring down an American institution." The longtime Ringling boss argues that he is the trustee of a tradition "older than baseball" that offers a vanishing commodity for American families: affordable G-rated entertainment.

Mr. Feld's legal victories ensure that the Ringling tradition will continue, but the larger winner is the cause of justice. A version of this article appeared December 31, 2012, on page A14 in the U.S. edition of The Wall Street Journal, with the headline: The Elephant in the Courtroom.
