Anne is a Life Member of the Atlanta Kennel Club, and she and Jim have been successful breeders and exhibitors of Twelfth Night Dachshunds for many years. [Jim] died peacefully on October 31, 2021, at Emory University Hospital with his family at his side. Jim had waged a successful war against CLL (chronic lymphocytic leukemia) for over twelve years, but he lost this final battle after changes in his disease became more than his body could overcome....After his retirement [from the position of Chairman and Chief Executive Officer of Carter & Associates] he was frequently found at dog shows all over the country, as he was very supportive of Anne's hobby of breeding and showing standard longhaired dachshunds. He even finished quite a few show champions himself and belonged to the Dachshund Club of Metropolitan Atlanta, The Dachshund Club of America, and the Atlanta Kennel Club.

AKC Legislative Alert—Harmful, Arbitrary Breeder Mandates Bill Advancing – Contact Your Representatives

From AKC Government Relations:

A set of arbitrary and harmful federal breeder bills (H.R. 2840/S. 1385) that would mandate new requirements for certain hobby and professional dog breeders are gaining support in Congress. We urge all responsible dog owners, breeders and enthusiasts to contact their lawmakers about the harmful consequences of the bills.

What you Can Do:

Most members of Congress want to do the right thing for dogs, but they are not experts in this area. It's likely they do not understand the nuances or unintended consequences of arbitrary legislation that may "sound good" to a non-expert. They also hear a lot from animal rights/ animal protection groups, and they also rely on hearing from constituents. Unless we help educate our lawmakers, we will be subject to bad laws.

Your member of Congress needs to hear from you. Please contact your member of Congress and your U.S. Senators today. Visit AKC's Legislative Action Center, scroll down to the bottom right, and type your address in the "Find Your Elected Officials" box to find out who represents you and get their contact information. You can also compose and send a message to your representatives directly from this page.

Tell them:

- 1. H.R. 2840/S. 1385 mandate arbitrary one-size-fits-all requirements for temperatures, kennel engineering standards, and breeding bans that are not appropriate for all types or breeds of dogs and could harm some dogs.
- Explain you are a constituent. Respectfully share your experience and concerns as a dog owner/breeder/expert and based on the talking points above. Breeders: Relying on your experience, explain in practical terms how the new mandates would adversely impact your breeding program.
- 3. Ask them to not support advancing the bills out of committee.
- 4. If you can, let the AKC GR team (doglaw@akc.org) know you contacted your lawmakers and if you received any response.
