Estate Planning—November Meeting Program

Our speaker in November was Oren Ross II Esq., MBA. He specializes in estate planning, wills and trusts. He discussed planning for pets as part of complete estate planning. He has kindly shared his slides with us to publish in the Digest. The most important points he made were (1) make sure you have a will tailored to your circumstances, and (2) make sure you have a plan for your pets in the event that you pre-decease them.

AVOIDING THE 3 BIGGEST ESTATE PLANNING MISTAKES

PROBATE IN GEORGIA

Wills go through Probate

A Will instructs the Probate Court as to your wishes

Multiple steps: validating Will, having legal heirs sign off, publishing notice for creditors, possible Will contests, filing inventories & accountings

- Beneficiaries & the Court need to sign off on every step of the estate.
- Getting Letters Testamentary is NOT the end of probate; it is the beginning.

No Will? Intestate Probate

- State decides where assets go split among spouse & children, or closest family members
- Race to decide who will be Administrator

Assets are frozen until Probate Court appoints a Personal Representative for the estate (Executor or Administrator)

• Sale of Real Estate requires approval by Court, which can take months

FAQS - PROBATE

How long does probate take?

• Before coronavirus, the average in GA was 12 months. Courts are still backlogged.

How much does probate cost?

- Court costs: a few hundred dollars
- Attorneys' Fees: "Reasonableness" standard \$250-\$450 per hour, no real limitation. \$10,000-\$15,000 is not uncommon. Joint Tenancy (JTWROS)
 - Avoids probate when 1st spouse dies, but not when 2nd dies
 - Capital gains tax issues
 - 2nd Marriage issues

Lack of Privacy – all assets, debts, expenses, & inheritances become public record 1989 AARP study – \$2 billion / year in probate expenses, recommended Living Trusts

REVOCABLE LIVING TRUSTS

No change to daily life - maintain full access to assets; no tax changes; keep Homestead & Senior exemptions

When first spouse dies, 2nd spouse maintains full control – unless you don't want that

• Possible remarriage, or blended family – imperative to avoid probate

When 2nd spouse dies, all Trust assets pass outside of Probate

- Assets retitled into a Trust: real estate, bank & brokerage accounts, businesses, valuable items or collections, etc.
- Assets not retitled into a Trust: IRAs, 401(k)s, Life Insurance, Annuities
 - A Trust can be a beneficiary of these accounts

Pour Over Will: covers cars, household & personal items

Certification of Trust: given to banks, brokerages, insurance companies to prove that the Trust exists & who the Trustees are

INHERITANCE TRUSTS

Not just for children; can be used for anyone, of any age, including non-family members

Divorce-Proof Inheritance

- Spouse has no access, no control, cannot be considered marital property
- Also protects the inheritance from Creditors

Keep Money/Property in Family, even if Child dies

- Prevents Spouse from spending it on Their Next Spouse
- Keep it in Trust for Their Children, or Their Siblings, or A Charity

Control How Much They Get, and When They Get It

- Monthly or Yearly Distributions, or name an Age or Milestone when they can access
- Beneficiaries have a right to assets for Health, Education, Maintenance, and Support (Trustee decides what is appropriate)

I include 2 Inheritance Trusts FREE as part of the Revocable Living Trust Package

SPECIAL / SUPPLEMENTAL NEEDS TRUST

Prevent Assets from being spent down in order to qualify for government assistance

Special Needs Trust allows Beneficiary to keep Government Benefits AND their Inheritance

• Usually a Family Member is Trustee to decide what assets are spent on

Assets can be spent on anything except Food & Shelter (Government Benefits cover those)

I include 1 Special Needs Trust FREE as part of the Revocable Living Trust Package

PET TRUSTS

Legally enforceable & private; does not require Probate Court approval

Name a Trustee and a Caregiver for Pets

- Trustee can oversee Caregiver & ensure proper care
- Trustee manages assets

Pet Trust can apply a specific amount of money per month or year for Pets' care, and give Trustee the ability to pay more if needed for health, maintenance, and support

Give General and Specific Guidelines for Pets' care

- Housing, Food, Medical Needs, Grooming, Training, Exercise, Toys, etc.
- Breeding: Semen storage methods & use; Limiting lease types & number of litters
- Events: Preferred Shows, Sports, Title Recognition Programs

Co-ownership: Can create & fund a Pet Trust with other owners

POWER OF ATTORNEY & ADVANCE DIRECTIVE FOR HEALTHCARE

Needed for anyone over 18

Financial Power of Attorney (2017) - can now force acceptance of POA

• Name an agent to pay bills, manage finances if you're incapacitated

Advance Directive for Healthcare (2009) – Healthcare "power of attorney"

- Name an agent to speak to your doctors, consent to surgery, etc.
- Also includes Living Will you can determine outcome if you're on life support or have a terminal condition
